To: OWNERS/OCCUPIERS OF THE CLAIMED BYWAYS OPEN TO ALL TRAFFIC FROM MAPRIDGE GREEN LANE TO COBBLERSHILL LANE AND FROM THE GREAT MISSENDEN/WENDOVER PARISH BOUNDARY TO THE A413

Notice of the above Order, made on 4 January 2011, was served on 17 January 2011. It is necessary to re-serve the notice because the route of the Byway Open To All Traffic is unregistered and notice has not been brought to the attention of any possible landowner. If confirmed as made, the order will modify the definitive map and statement for the area by upgrading to Byways Open To All Traffic the bridleways described in the schedule below.

A copy of the Order and the Order map may be seen free of charge at County Hall, Aylesbury and at Great Missenden Library, High Street, Great Missenden and Wendover Library, High Street, Wendover during normal opening hours.

Copies of the Order and map may be purchased from the County Council at a cost of £20.00 at the address given below.

Any representation or objection relating to the Order previously submitted remains valid. Should any additional representation or objection be forthcoming it must be sent in writing to Anne Davies at the address given below not later than 11 January 2012, and applicants are requested to state the grounds on which it is made.

If no representations or objections are duly made to the Order, or to any part of it, or if any so made are withdrawn, the Buckinghamshire County Council instead of submitting the Order to the Secretary of State for Environment, Food, and Rural Affairs may itself confirm the Order. If the Order is submitted to the Secretary of State, any representations or objections which have been duly made and not withdrawn will be sent with it.

Under the Local Government (Access to Information) Act 1985 this Council is obliged to make any representations received in response to this notice, open to public inspection.

**SCHEDULE**

**Description of Bridleways to be upgraded to Byways Open To All Traffic**

From point A on the Order map at the junction with the public road section of Mapridge Green Lane at SP8803-0249 generally north north west for approximately 492 metres to point C at the Great Missenden/Wendover parish boundary at SP8784-0295 then north west for approximately 1170 metres to point B at its junction with Cobblershill Lane at SP8696-0366 as shown by a brown line and having a width varying between 3 and 11 metres.

From point C at SP8784-0295 generally north east for approximately 521 metres to point E at the Great Missenden/Wendover parish boundary at SP8825-0320 then north east for approximately 244 metres to point D at its junction with the A413 at SP8846-0331 as shown by a brown line and having a width varying between 3 and 11 metres.
