(PUBLIC FOOTPATH NO. 57, PARISH OF CHARTRIDGE AND NO. 85  
CHESHAM) PUBLIC PATH DIVERSION ORDER 2011**

The above Order, made on 9 August 2011, under section 119 of the Highways Act 1980, will divert the public footpaths described in the Schedule below.

A copy of the order and the order map have been placed and may be seen free of charge at County Hall, Aylesbury and Chesham Library, Elgiva Lane, Chesham during normal opening hours. Copies of the order and map may be purchased from the County Council at a cost of £20.00 at the address given below.

Any representations about or objections to the Order may be sent in writing to the Head of Legal and Democratic Services at the address given below, not later than 15 September 2011. Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Buckinghamshire County Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the Order.

Under the Local Government (Access to Information) Act 1985 this Council is obliged to make any representations received in response to this notice, open to public inspection.

**SCHEDULE**

**DESCRIPTION OF SITE OF EXISTING PATHS OR WAYS**

**Public Footpath No. 57 Parish of Chartridge**

**A-C-Y-B**

From point A on the order map at SP 9500-0367 in a north easterly direction for approximately 144 metres to point C at SP 9512-0375 then in a north north easterly direction for approximately 34 metres to point Y at SP 9513-0378 then in a north north westerly direction for approximately 88 metres to point B at SP 9510-0386 as shown by a bold continuous line.

**C-D**

From point C on the order map at SP 9512-0375 in a south easterly direction for approximately 7 metres to point D at SP 9513-0375 as shown by a bold continuous line.

**Public Footpath No. 85 Chesham**

**D-E**

From point D on the order map at SP 9513-0375 in a generally south easterly direction for approximately 98 metres to point E at SP 9521-0370 as shown by a bold continuous line.

## DESCRIPTION OF SITE OF NEW PATHS OR WAYS

### **Public Footpath No. 57 Parish of Chartridge**

#### **I-J-K-X-L**

From point I on the order map at SP 9513-0375 in a northerly direction for approximately 82 metres to point K at SP 9514-0383 then in a north north westerly direction for approximately 51 metres to point L at SP 9512-0387 as shown by a bold broken line and having a width of 2 metres throughout.

### **Public Footpath No. 85 Chesham**

#### **A-F-G-H-I**

From point A on the order map at SP 9500-0367 in an easterly direction for approximately 12 metres to point F at SP 9501-0367 then in a generally north easterly direction for approximately 145 metres to point I at SP 9513-0375 as shown by a bold broken line and having a width of 2 metres throughout.

### **Public Footpath No.85 Chesham**

#### **G-M-N-E**

From point G on the order map at SP 9512-0374 in a generally south easterly direction for approximately 99 metres to point E at SP 9521-0370 as shown by a bold broken line and having a width of 2 metres throughout.
