**KIMBLE) PUBLIC PATH DIVERSION ORDER 2011**

The above Order, made on 17 May 2011, under section 119 of the Highways Act 1980, will divert the public footpaths described in the schedule below.

A copy of the order and the order map have been placed and may be seen free of charge at County Hall, Aylesbury and Princes Risborough Library, Bell Street, Princes Risborough during normal opening hours. Copies of the order and map may be purchased from the County Council at a cost of £20.00 at the address given below.

Any representations about or objections to the Order may be sent in writing to the Head of Legal and Democratic Services at the address given below, not later than 5 October 2011. Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Buckinghamshire County Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the Order.

Under the Local Government (Access to Information) Act 1985 this Council is obliged to make any representations received in response to this notice, open to public inspection.

**SCHEDULE**

**DESCRIPTION OF SITE OF EXISTING PATHS OR WAYS**

**Public Footpath No. 36A Great and Little Kimble**

**A-B**

From point A on the order map at SP8164-0712 in a south easterly direction for approximately 383 metres to point B at SP8190-0684 as shown by a bold continuous line.

**Public Footpath No. 36 Great and Little Kimble**

**B-C**

From point B on the order map at SP8190-0684 in a generally east south easterly direction for approximately 301 metres to point C at SP8217-0675 as shown by a bold continuous line.

**DESCRIPTION OF SITE OF NEW PATHS OR WAYS**

**Public Footpath No. 36A Great and Little Kimble**

**D-E-F**

From point D on the order map at SP8164-0712 in a south easterly direction for approximately 387 metres to point F at SP8190-0685 as shown by a bold broken line and having a width of 2 metres throughout.

**Public Footpath No. 36 Great and Little Kimble**

**F-G-H-I-J-K-L**

From point F on the order map at SP 8190-0685 in a south easterly direction for approximately 34 metres to point G at SP8193-0683 then in a north easterly direction for approximately 228 metres to point J at SP8214-0692 then in an easterly direction for approximately 115 metres to point L at SP8226-0690 as shown by a bold broken line and having a width of 2 metres throughout.
