

**THE BUCKINGHAMSHIRE COUNTY COUNCIL**  
**SPEED LIMIT REVIEW (VARIOUS ROADS, VARIOUS PARISHES IN AREA 12: PHASE 2)**  
**(30MPH, 40MPH AND 50MPH SPEED LIMIT) ORDER 2011**

**BUCKINGHAMSHIRE COUNTY COUNCIL** (hereinafter referred to as "the Council") in exercise of its powers under Sections 84(1)(a), (2) and section 9(4) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and having regard to Section 122 of the Act, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of roads specified in Schedule One to this Order.
2. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of roads specified in Schedule Two to this Order.
3. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of roads specified in Schedule Three to this Order.
4. This Order may be cited as "The Buckinghamshire County Council Speed Limit Review (Various Roads, Various Parishes in Area 12: Phase 2)(30mph, 40mph and 50mph Speed Limit) Order 2011" and shall come into operation on 16<sup>th</sup> December 2011.
5. The Orders specified in Schedule Four of this Order are hereby revoked.
6. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order, any speed limits operative prior to this Order coming into effect, relating to the roads specified in Schedule One, Schedule Two and Schedule Three to this Order are revoked to the extent that this Order takes effect.
7. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.


