

THE BUCKINGHAMSHIRE COUNTY COUNCIL
SPEED LIMIT POST IMPLEMENTATION REVIEW (VARIOUS ROADS, VARIOUS
PARISHES IN AREA 7) (30 MPH AND 40MPH SPEED LIMIT) ORDER 200

Notice is hereby given that Buckinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984. The effect of the Order will be to impose a **30 miles per hour speed restriction** on the length of road specified in Schedule One below and to impose a **40 miles per hour speed restriction** on the lengths of road specified in Schedule Two below.

This Order provides for the revocation of "The Buckinghamshire County Council (A4129 and Haddenham Road, Kingsey) (40mph Speed Limit) Order, 2004" insofar as it relates to Haddenham Road and "The Buckinghamshire County Council (Various Roads, Various Parishes in Area 7) (50mph Speed Limit) Order, 2007" insofar as it relates to C141 London Road/B4009 Tring Hill, Buckland/Drayton Beauchamp.

A copy of the Order and maps showing the lengths of road referred to, together with the Statement of Reasons for proposing to make the Order may be inspected during normal office hours at County Hall, Aylesbury and during normal opening hours at the following libraries: Aylesbury Study Centre, County Offices, Walton Street, Aylesbury; Wendover Library, High Street, Wendover; Haddenham Library, Churchway, Haddenham.

Objections to or support for the proposals together with the grounds on which they are made must be sent in writing to the undersigned by 6 May 2009, marked for the attention of Laura Witney, Legal Assistant, Legal and Democratic Services, County Hall, Aylesbury, Bucks, HP20 1UA.

Under the Local Government (Access to Information) Act 1985 this Council is obliged to make any representations received in response to this notice, open to public inspection.

<u>Name of Road and Parish</u>	<u>Length of Road Affected</u>
C66 Haddenham Road, Kingsey	From its junction with A4129 for a distance of 448 metres.

SCHEDULE TWO

<u>Name of Road and Parish</u>	<u>Length of Road Affected</u>
A418 Scotsgrove Hill/Aylesbury Road, Haddenham	From a point 437 metres southwest of its junction with C70 Thame Road (200 metres southwest of the access to Scotsgrove House) to a point 185 metres north of that junction (a distance of 622 metres).
C70 Thame Road, Scotsgrove, Haddenham	From its junction with A418 Scotsgrove Hill/Aylesbury Road to a point 177 metres northeast of its junction with Mill Lane,
C141 London Road/B4009 Tring Hill, Buckland/Drayton Beauchamp	From a point 168 metres west of its junction with Upper Icknield Way to a point 53 metres west of the roundabout junction at Tring Hill Interchange.
