

THE BUCKINGHAMSHIRE COUNTY COUNCIL
SPEED LIMIT REVIEW (VARIOUS ROADS, VARIOUS PARISHES IN AREA 9) (FURTHER PROPOSALS FOR A40, BEACONSFIELD/WOORBURN) (40 MPH AND 50MPH SPEED LIMIT) ORDER 200

Notice is hereby given that Buckinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984. The effect of the Order will be to impose a **40 miles per hour speed restriction** on the length of road specified in Schedule 1 below and to impose a **50 miles per hour speed restriction** on the length of road specified in Schedule 2 below.

This Order provides for the revocation of "The Buckinghamshire County Council Speed Limit Review (Various Roads, Various Parishes in Area 9)(50mph Speed Limit) Order, 2008" insofar as it relates to that length of A40 known as White Hill, Wooburn Moor and London Road/Wycombe End, Beaconsfield/Wooburn, between a point 167 metres east of its junction with Whitehouse Lane, Loudwater and a point 301 metres west of its junction with Windsor End, Beaconsfield.

A copy of the Order and maps showing the lengths of road referred to, together with the Statement of Reasons for proposing to make the Order may be inspected during normal office hours at County Hall, Aylesbury and during normal opening hours at Beaconsfield Library, Reynolds Road, Beaconsfield.

Objections to or support for the proposals together with the grounds on which they are made must be sent in writing to the undersigned by 12 December 2008, marked for the attention of Laura Witney, Legal Assistant, Legal and Democratic Services, County Hall, Aylesbury, Bucks, HP20 1UA.

Under the Local Government (Access to Information) Act 1985 this Council is obliged to make any representations received in response to this notice, open to public inspection.

<u>Name of Road and Parish</u>	<u>Length of Road Affected</u>
A40, Beaconsfield/Wooburn	From a point 63 metres west of its junction with the B4440 Wooburn Green Lane, Holtspur, to a point 301 metres west of its junction with Windsor End, Beaconsfield.

SCHEDULE 2

<u>Name of Road and Parish</u>	<u>Length of Road Affected</u>
A40 White Hill, Beaconsfield/Wooburn	Between a point 167 metres east of its junction with Whitehouse Lane and a point 63 metres west of its junction with the B4440 Wooburn Green Lane, Holtspur.
